

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC5511000014 – DelDOT Administration Building – Renovation and OCR Compliance Project** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Thursday, December 15, 2016, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves renovating select areas of the DelDOT Administration Building East Wing. Renovations included ADA improvements (interior and exterior), office renovations, electrical and IT distribution for new cubicle areas as well as new perimeter system furniture offices. All furniture and systems furniture will be provided by Owner under separate contract. General Contractor is responsible to coordinate furniture and systems furniture vendor in this contract. Renovations also include new wall finishes. Floor finishes will be provided by Owner under separate contract. General Contractor is responsible to coordinate floor finishes vendor in this contract.

A **MANDATORY** Pre-Bid Meeting will be held on Tuesday, November 29, 2016, at 9:00 a.m. at the DelDOT Administration Building, 800 Bay Road, Dover, Delaware, for the purpose of reviewing existing field conditions, establishing the list of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**

Sealed bids shall be addressed to the Division of Facilities Management, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901. The successful bidder must post a performance bond and payment bond in a sum equal to 100 percent of the contract price upon execution of the contract. The Owner reserves the right to reject any or all bids and to waive any informalities therein. The Owner may extend the time and place for the opening of the bids from that described in the advertisement, with not less than two calendar days notice by certified delivery, facsimile machine or other electronic means to those bidders receiving plans.
