

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MJ1002000007 – Legislative Hall – HVAC Renovations** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:30 p.m. local time on Monday, April 15, 2013, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the following at Legislative Hall located in Dover, Delaware: installation of modular air handling units, base-mounted pumps, VAV boxes, cooling tower, a third modular to the existing multi-stack chiller, complete BAS system, all associated piping, wiring and demolition.

Attention is called to construction schedule as detailed in the Bid Documents.
