

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MJ1002000002 – Kent County Courthouse – Asbestos Abatement**, will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Tuesday, May 10, 2011, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves asbestos abatement in preparation for renovations to the Kent County Courthouse located in Dover, Delaware.

Attention is called to construction schedule as detailed in the Bid Documents.

A **MANDATORY** Pre-Bid Meeting will be held on Tuesday, April 19, 2011, at **6:30 a.m. SHARP** at the Kent County Courthouse, 38 The Green, Dover, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT. This is a secure facility. The contractor's representative must be at the entrance door adjacent to The Green by 6:30 a.m. SHARP. Late representatives will not be admitted to the mandatory pre-bid meeting because the contractors must be escorted through the building. Cell phones are not permitted in the courthouse; however cameras will be allowed.**

Sealed bids shall be addressed to the Division of Facilities Management, 540 S. DuPont Highway, Suite 1, Dover, DE 19901. The outer envelope should clearly indicate: **"OMB/DFM CONTRACT MJ1002000002 – KENT COUNTY COURTHOUSE – ASBESTOS ABATEMENT - SEALED BID - DO NOT OPEN."**
