

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MJ1002000010 – Williams State Service Center – Roof Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Tuesday, December 29, 2015, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves roof replacement at the Williams State Service Center located in Dover, Delaware, which consists of removing the existing roof systems in their entirety to roof deck; removing existing precast coping from roof parapet walls and site wall; providing and installing new cold-applied SBS modified bituminous membrane roof system and related ancillary components including manufactured metal coping.

A **MANDATORY** Pre-Bid Meeting will be held on Tuesday, December 8, 2015, at 9:00 a.m. at the Facilities Management office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. A visit to the project site, which is adjacent to the Collins Building, will be conducted after the meeting. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**
