

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MJ1002000022 – Amoco Building – Roof Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Thursday, October 26, 2017, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

The project involves the following at the Amoco Building located in New Castle, Delaware: removal of the existing ballasted EPDM roof system in its entirety down to existing wood and/or metal decks, including existing roof edge metal fascia; furnish and install new cold applied, 2-ply SBS modified bituminous membrane roof system complete with new roof edge metal fascia; perform repairs to the existing roof overhang soffit and fascia system, including provision of new soffit vents. The project is separated into base bid, plus five additive alternates.

A **MANDATORY** Pre-Bid Meeting will be held on Wednesday, October 11, 2017, at 10:00 a.m. at the Amoco Building, 715 Grantham Lane, New Castle, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**

The Owner reserves the right to reject any or all bids and to waive any informalities therein. The Owner may extend the time and place for the opening of the bids from that described in the advertisement, with not less than two calendar days notice by certified delivery, facsimile machine or other electronic means to those bidders receiving plans.
