

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MJ1002000023 – Sussex County Elections Building – Roof Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 10:30 a.m. local time on Tuesday, August 29, 2017, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

The project involves the following at the Sussex County Elections Building located in Georgetown, Delaware: removal of the existing R-Mer-Lite metal roof system in its entirety down to existing structural metal deck; removal of the existing brick chimney to below the structural deck and infill the resulting opening with like-kind metal deck; furnish and install a new cold-applied, 2-ply, SBS modified bituminous membrane roof system complete with new metal copings, formed metal roof edges, gutters and downspouts.

A **MANDATORY** Pre-Bid Meeting will be held on Thursday, August 10, 2017, at 1:00 p.m. at the Sussex County Elections Building, 119 North Race Street, Georgetown, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**

Sealed bids shall be addressed to the Division of Facilities Management, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901.
