

## **ADVERTISEMENT FOR BIDS**

Sealed bids for **OMB/DFM Contract No. MC1002000315 – Delaware State Fire School – HVAC Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (3<sup>rd</sup> Floor), Dover, DE 19901 until 2:30 p.m. local time on Monday, November 27, 2017, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

The project involves the replacement of the existing HVAC system at the Delaware State Fire School in Dover, Delaware.

The successful bidder must post a performance bond and payment bond in a sum equal to 100 percent of the contract price upon execution of the contract. The Owner may extend the time and place for the opening of the bids from that described in the advertisement, with not less than two calendar days notice by certified delivery, facsimile machine or other electronic means to those bidders receiving plans.
