- 5. The fence surrounding the patio has dislodged the concrete coping stone from the top of the parapet wall in the southwest corner of the patio. The plate attaching the fencepost to the concrete coping stone will need to be removed and a new support plate will need to be secured to the brick down below, additionally a 24 gauge galvanized strap will be required to be fastened into the wall above the fence. Also the concrete coping stone will need to be remounted on top of the parapet wall at this location. Photos of this condition are attached.
