 - 4.2 Drawing E15-02: Springer Building Partial Floor Plan
 1. DELETE current drawing and REPLACE with new drawing attached. Changes are bubbled.
- 5.0 Questions/Clarifications
 - 5.1 Sheet No. E11-02 Shows a PHM 3 with 2 switching mechanisms and Auto Transfer for the Springer Building. We believe the intent was for 1 switched way and no auto transfer.
REPLY: See Article 4.1 above.
 - 5.2 Is there any additional information on the 500KVA PCB contaminated transformer?
REPLY: Yes, this is a 75kVA substation class transformer. See below for photos and refer to Specification Section 02 84 00.13-3.08 for further details.
