ARTICLE 1: GENERAL

- 1.1 DEFINITIONS
- 1.1.1 Whenever the following terms are used, their intent and meaning shall be interpreted as follows:
- 1.2 STATE: The State of Delaware.
- 1.3 AGENCY: Contracting State Agency as noted on cover sheet.
- 1.4 DESIGNATED OFFICIAL: The agent authorized to act for the Agency.
- BIDDING DOCUMENTS: Bidding Documents include the Bidding requirements and the proposed Contract Documents. The Bidding Requirements consist of the Advertisement for Bid, Invitation to Bid, Instructions to Bidders, Supplementary Instructions to Bidders (if any), General Conditions, Supplementary General Conditions, General Frequirements, Special Provisions (if any), the Bid Form (including the Non-collusion Statement), and other sample bidding and contract forms. The proposed Contract Polyments consist of the form of Agreement between the Owner and Contractor, as well as the Drawings, Specifications (Project Manual) and all Addenda issued prior to execution of the Contract.
- 1.6 CONTRACT DOCUMENTS: The Contrac Pocuments consist of the, Instructions to Bidders, Supplementary Instructions to Bidders (if any), General Conditions, Supplementary General Conditions, General Requirements, Special Provisions (if any), the form of agreement between the Owner and the Confractor, Drawings (if any), Specifications (Project Manual), and all addenda.
- AGREEMENT: The form of the Ag. ** ment shall be AIA Document A101, Standard Form of Agreement between Owne. and Contractor where the basis of payment is a STIPULATED SUM. 3.2 INTERPRETATION OR CORRECTION OF BIDDING DOCUMENTS

- 3.2.1 The Bidder shall carefully study and compare the Bidding Documents with each other, and with other work being bid concurrently or presently under construction to the extent that i' relates to the Work for which the Bid is submitted, shall examine the site and loca conditions, and shall report any errors, inconsistencies, or ambiguities discovered to \(\overline{\chi}\) e Architect.
- Bidders or Sub-bidders requiring clarification or interpretation of the Bidding Documents shall make a written request to the Architect at least seven days prior to the data for receipt of Bids. Interpretations, corrections and changes to the Bidding Documents will be unade by written Addendum. Interpretations, corrections, or changes to the Bidding Documents made in any other manner shall not be binding.
- 3.2.3 The apparent silence of the specifications as to any detail, or the cope ent omission from it of detailed description concerning any point, shall be regarded as in sening that only the best commercial practice is to prevail and only material and workn anship of the first quality are to be used. Proof of specification compliance will be the responsibility of the Bidder.
- 3.2.4 Unless otherwise provided in the Contract Documents, the Contractor shall provide and pay for all permits, labor, materials, equipment, thous, construction equipment and machinery, water, heat, utilities, transportation, and other faculties and services necessary for the proper execution and completion of the Work.
- 3.2.5 The Owner will bear the costs for all in pact and user fees associated with the project.

3.3 SUBSTITUTIONS

- 3.3.1 The materials, products and equipment described in the Bidding Documents establish a standard of quality, required function, dimension, and appearance to be met by any proposed substitution. The pecification of a particular manufacturer or model number is not intended to be proprietable in any way. Substitutions of products for those named will be considered, providing that the Vendor certifies that the function, quality, and performance characteristics of the material offered is equal or superior to that specified. It shall be the Bidder's esponsibility to assure that the proposed substitution will not affect the intent of the design, and to make any installation modifications required to accommodate the substitution.
- 3.3.2 Fecuests for substitutions shall be made in writing to the Architect at least ten days prior to the date of the Bid Opening. Such requests shall include a complete description of the proposed substitution, drawings, performance and test data, explanation of required installation modifications due the substitution, and any other information necessary for an evaluation. The burden of proof of the merit of the proposed substitution is upon the proposer. The Architect's decision of approval or disapproval shall be final. 4.2 BID SECURITY

- All bids shall be accompanied by a deposit of either a good and sufficient bond to the agency for the benefit of the agency, with corporate surety authorized to do business in this State, the form of the bond and the surety to be approved by the agency, or a security of the bidder assigned to the agency, for a sum equal to at least 10% of the bid plus all acid alternates, or in lieu of the bid bond a security deposit in the form of a certified check treasurer's check, cashier's check, money order, or other prior approved secured deposit assigned to the State. The bid bond need not be for a specific sum, but may he size tea to be for a sum equal to 10% of the bid plus all add alternates to which it relates and not to exceed a certain stated sum, if said sum is equal to at least 10% of the bid. The Fig Point form used shall be the standard OMB form (attached).
- The Agency has the right to retain the bid security of Bidders to whom, an award is being considered until either a formal contract has been executed and honds have been furnished or the specified time has elapsed so the Bids may be withdraw. In all Bids have been rejected.
- 4.2.3 In the event of any successful Bidder refusing or neglecting to execute a formal contract and bond within 20 days of the awarding of the contract, the bid bond or security deposited by the successful bidder shall be forfeited.

4.3 SUBCONTRACTOR LIST

- 4.3.1 As required by <u>Delaware Code</u>, Title 29, sec ion 6962(d)(10)b, each Bidder shall submit with their Bid a completed List of Syp-Conunc ors included with the Bid Form. NAME ONLY ONE SUBCONTRACTOR FOR FACH TRADE. A Bid will be considered non-responsive unless the completed list is included
- 4.3.2 Provide the Name and Address or each listed subcontractor. Addresses by City, Town or Locality, plus State, will be a ceptable.
- It is the responsibility of the Contractor to ensure that their Subcontractors are in compliance with the provisions of this law. Also, if a Contractor elects to list themselves as a Subcontractor for any category, they must specifically name themselves on the Bid Form and be the to document their capability to act as Subcontractor in that category in accordance with this law.
- 4.4 FQUALITY OF EMPLOYMENT OPPORTUNITY ON PUBLIC WORKS
- 4.4.1 During the performance of this contract, the contractor agrees as follows:
 - A. The Contractor will not discriminate against any employee or applicant for employment because of race, creed, color, sex or national origin. The Contractor will take affirmative action to ensure the applicants are employed, and that employees are treated during employment, without regard to their race, creed, color, sex or national origin. Such action shall include, but not be limited to, the following: Employment, upgrading, demotion or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. The Contractor agrees to post in conspicuous places available to employees and applicants for employment notices to be provided by the contracting agency setting forth this nondiscrimination clause.

B. The Contractor will, in all solicitations or advertisements for employees placed by or on behalf of the Contractor, state that all qualified applicants will receive consideration for employment without regard to race, creed, color, sex or national origin."

4.5 PREVAILING WAGE REQUIREMENT

- 4.5.1 Wage Provisions: In accordance with <u>Delaware Code</u>, Title 29, Section 6960, ren. validation projects whose total cost shall exceed \$15,000, and \$100,000 for new construction, the minimum wage rates for various classes of laborers and mechanics shall be a section ined by the Department of Labor, Division of Industrial Affairs of the State of Delaware.
- The prevailing wage shall be the wage paid to a majority of employed a performing similar work as reported in the Department's annual prevailing wage survey or in the absence of a majority, the average paid to all employees reported.
- The employer shall pay all mechanics and labors employed direc.'v upon the site of work, unconditionally and not less often than once a week ar u w hout subsequent deduction or rebate on any account, the full amounts accrued at tin. a or payment, computed at wage rates not less than those stated in the specifications, regardless of any contractual relationship which may be alleged to exist between the employer and such laborers and mechanics.
- The scale of the wages to be paid shall be posted by the employer in a prominent and easily accessible place at the site of the work.
- 4.5.5 Every contract based upon these specimes on shall contain a stipulation that sworn payroll information, as required by the Legrartment of Labor, be furnished weekly. The Department of Labor shall keep and maintain the worn payroll information for a period of 6 months from the last day of the work weekly sovered by the payroll.

4.6 SUBMISSION OF BIL'S

- 4.6.2 Deposit Bids at the designated location prior to the time and date for receipt of bids indicated in the Advertisement for Bids. Bids received after the time and date for receipt of bids will be marked "LATE BID" and returned.
- 4.6.3 Bidder assumes full responsibility for timely delivery at location designated for receipt of bids.
- Oral, telephonic or telegraphic bids are invalid and will not receive consideration.
- 4.6.5 Withdrawn Bids may be resubmitted up to the date and time designated for the receipt of Bids, provided that they are then fully in compliance with these Instructions to Bidders.

4.7 MODIFICATION OR WITHDRAW OF BIDS

- 4.7.1 Prior to the closing date for receipt of Bids, a Bidder may withdraw a Bid by personal request and by showing proper identification to the Architect. A request for withdraw by letter or fax, if the Architect is notified in writing prior to receipt of fax, is acceptable. A fax directing a modification in the bid price will render the Bid informal, causing it to be ineligible for consideration of award. Telephone directives for modification of the bid price shall not be permitted and will have no bearing on the submitted proposal in any manner.
- 4.7.2 Bidders submitting Bids that are late shall be notified as soon as practicable and the shall be returned.
- A Bid may not be modified, withdrawn or canceled by the Bidder duing a thirty (30) day period following the time and date designated for the receipt and poeting of Bids, and Bidder so agrees in submitting their Bid. Bids shall be binding for a 3 days after the date of the Bid opening.

ARTICLE 5: CONSIDERATION OF BIDS

5.1 OPENING/REJECTION OF BIDS

- Unless otherwise stated, Bids received on time w." be publicly opened and will be read aloud. An abstract of the Bids will be made a ailuble to Bidders.
- The Agency shall have the right to reject any and all Bids. A Bid not accompanied by a required Bid Security or by other data required by the Bidding Documents, or a Bid which is in any way incomplete or irregular is subject to rejection.
- 5.1.3 If the Bids are rejected, it will be do. a within thirty (30) calendar day of the Bid opening.

5.2 COMPARISON OF BIDS

- After the Bids have been givened and read, the bid prices will be compared and the result of such comparirons will be made available to the public. Comparisons of the Bids may be based on the Pase Pid plus desired Alternates. The Agency shall have the right to accept Alternates in any order or combination.

They are not to be used by the Contractor or any Subcontractor, Sub-subcontractor or Material and Equipment Supplier on other Projects or for additions to this Project outside the scope of the Work without the specific written consent of the Owner, Architect and Architect's consultants.

The Architect shall not be liable for injury or damage resulting from the re-use of drawings and specifications if the Architect is not involved in the re-use Project. Prior to re-use of construction documents for a Project in which the Architect is not also involved, the Owner will remove from such documents all identification of the original Architect, including name, address and professional seal or stamp."

Delete Paragraph 1.5.2 in its entirety.

ARTICLE 2: OWNER

2.2 INFORMATION AND SERVICES REQUIRED OF THE OWNER

To Subparagraph 2.2.3 – Add the following sentence:

"The Contractor, at their expense shall bear the costs to accurately identify the location of all underground utilities in the area of their excavation and shall tear all cost for any repairs required, out of failure to accurately identify said utilities."

- 4.4.1 The Owner shall have the right to audit the bloks and records of a Contractor or any Subcontractor under any Contract or Subcontract to the extent that the books and records relate to the performance of the Contract or Subcontract.
- 4.4.2 Said books and records shall by maintained by the Contractor for a period of seven (7) years from the date of final paymes, under the Prime Contract and by the Subcontractor for a period of seven (7) years from the date of final payment under the Subcontract.

ARTICLE 5: SUBCONTRACTOR:

5.1 SUBCONTRACTING REQUIREMENTS

- All contracts for the construction, reconstruction, alteration or repair of any public building (not a roal, street or highway) shall be subject to the following provisions:
 - A contract shall be awarded only to a Bidder whose Bid is accompanied by a statement containing, for each Subcontractor category, the name and address (city or town and State only street number and P.O. Box addresses not required) of the subcontractor whose services the Bidder intends to use in performing the Work and providing the material for such Subcontractor category.
 - A Bid will not be accepted nor will an award of any Contract be made to any Bidder which, as the Prime Contractor, has listed itself as the Subcontractor for any Subcontractor unless:
 - A. It has been established to the satisfaction of the awarding Agency that the Bidder has customarily performed the specialty work of such Subcontractor category by artisans regularly employed by the Bidder's firm;
 - B. That the Bidder is duly licensed by the State to engage in such specialty work, if the State requires licenses; and

- C. That the Bidder is recognized in the industry as a bona fide Subcontractor or Contractor in such specialty work and Subcontractor category.
- 5.1.2 The decision of the awarding Agency as to whether a Bidder who list itself as the Subcontractor for a Subcontractor category shall be final and binding upon all Braces, and no action of any nature shall lie against any awarding agency or its emologies or officers because of its decision in this regard.
- After such a Contract has been awarded, the successful Bidder shall not substitute another Subcontractor for any Subcontractor whose name was set for the in the statement which accompanied the Bid without the written consent of the awarding a rency.
- No Agency shall consent to any substitution of Subcontractors well-as the Agency is satisfied that the Subcontractor whose name is on the Bidders accompanying statement:
 - A. Is unqualified to perform the work required;
 - B. Has failed to execute a timely reasonable Subcontract;
 - C. Has defaulted in the performance or the portion of the work covered by the Subcontract; or
 - D. Is no longer engaged in such business.

5.2 PENALTY FOR SUBSTITUTION OF SUBCONTRACTORS

Should the Contractor foil to utilize any or all of the Subcontractors in the Contractor's Bid statement in the performance or the Work on the public bidding, the Contractor shall be penalized in the amount of (I roject specific amount*). The Agency may determine to deduct payments of the penalty from the Contractor or have the amount paid directly to the Agency. Any penalty from it assessed against the Contractor may be remitted or refunded, in whole or in part, by the Agency awarding the Contract, only if it is established to the satisfaction of the Agency that the Subcontractor in question has defaulted or is no longer engaged in such business. No claim for the remission or refund of any penalty shall be granted unless an application in filed within one year after the liability of the successful Bidder accrues. All penalty amounts assessed and not refunded or remitted to the contractor shall be reverted to the Ctate.

ASBESTOS ABATEMENT

- The selection of any Contractor to perform asbestos abatement for State-funded projects shall be approved by the Office of Management and Budget, Division of Facilities Management pursuant to Chapter 78 of Title 16.
- 5.4 STANDARDS OF CONSTRUCTION FOR THE PROTECTION OF THE PHYSICALLY HANDICAPPED
- 5.4.1 All Contracts shall conform with the standard established by the Delaware Architectural Accessibility Board unless otherwise exempted by the Board.

5.5 CONTRACT PERFORMANCE

Any firm entering into a Public Works Contract that neglects or refuses to perform or fails to comply with its terms, the Agency may terminate the Contract and proceed to award new Contract or may require the Surety on the Performance Bond to comple a uncontract in accordance with the terms of the Performance Bond.

ARTICLE 6: CONSTRUCTION BY OWNER OR SEPARATE CONTRACTORS

- The Owner reserves the right to simultaneously perform other construction or operations related to the Project with the Owner's own forces, and to award epocale contracts in connection with other portions of the Project or other Projects at the same site.
- The Contractor shall afford the Owner and other Contractors reconnable opportunity for access and storage of materials and equipment, and for the performance of their activities, and shall connect and coordinate their activities with other forces as required by the Contract Documents.

ARTICLE 7: CHANGES IN THE WORK

- 7.1 The Owner, without invalidating the Contract, mov order changes in the Work consisting of Additions, Deletions, Modifications of Substitutions, with the Contract Sum and Contract completion date being adjusted acronology. Such changes in the Work shall be authorized by written Change Order signed by the Professional, as the duly authorized agent, the Contractor and the Owner.
- 7.2 The Contract Sum and Connact Completion Date shall be adjusted only by a fully executed Change Order.
- The additional cost, or cleart to the Owner resulting from a change in the Work shall be by mutual agreement of the Owner, Contractor and the Architect. In all cases, this cost or credit shall be has a contine 'DPE' wages required and the "invoice price" of the material deglipment needed.
- 7.3.1 "D' E" shall be defined to mean "direct personnel expense". Direct payroll expense includes ure t salary plus customary fringe benefits (prevailing wage rates) and documented tatute y costs such as workman's compensation insurance, Social Security/Medicare, and un imployment insurance (a maximum multiplier of 1.35 times DPE).
- 7.3.2 "Invoice price" of materials/equipment shall be defined to mean the actual cost of materials and/or equipment that is paid by the Contractor, (or subcontractor), to a material distributor, direct factory vendor, store, material provider, or equipment leasing entity. Rates for equipment that is leased and/or owned by the Contractor or subcontractor(s) shall not exceed those listed in the latest version of the "Means Building Construction Cost Data" publication.
- 7.3.3 In addition to the above, the General Contractor is allowed a fifteen percent (15%) markup for overhead and profit for additional work performed by the General Contractor's own forces. For additional subcontractor work, the Subcontractor is allowed a fifteen (15) percent overhead and profit on change order work above and beyond the direct costs stated previously. To this amount, the General Contractor will be allowed a mark-up not exceeding seven and one half percent (7.5%) on the subcontractors work. These mark-

ups shall include all costs including, but not limited to: overhead, profit, bonds, insurance, supervision, etc. No markup is permitted on the work of the subcontractors subcontractor. No additional costs shall be allowed for changes related to the Contractor's onsite superintendent/staff, or project manager, unless a change in the worl changes the project duration and is identified by the CPM schedule. There will be no other costs associated with the change order.

ARTICLE 8: TIME

- Time limits, if any, are as stated in the Project Manual. By executing the Agreement, the Contractor confirms that the stipulated limits are reasonable, and that the Vicak will be completed within the anticipated time frame.
- If progress of the Work is delayed at any time by changes ordered by the Owner, by labor disputes, fire, unusual delay in deliveries, abnormal advise weather conditions, unavoidable casualties or other causes beyond the Contractor's council, the Contract Time shall be extended for such reasonable time as the Owner may determine.
- Any extension of time beyond the date fixed for completion of the construction and acceptance of any part of the Work called for by the Contract, or the occupancy of the building by the Owner, in whole or in part, previous to the completion shall not be deemed a waiver by the Owner of his right to annul or terminate the Contract for abandonment or delay in the matter provided for, nor relieve the Contractor of full responsibility.

8.4 SUSPENSION AND DEBARMENT

- Per Section 6962(d)(14), Title 2. Delaware Code, "Any Contractor who fails to perform a public works contract or complete a public works project within the time schedule established by the Agency in the Invitation To Bid, may be subject to Suspension or Debarment for one or more or the following reasons: a) failure to supply the adequate labor supply ratio for the project; it inadequate financial resources; or, c) poor performance on the Project."
- "Upon such falure for any of the above stated reasons, the Agency that contracted for 8.4.2 the public yerks project may petition the Director of the Office of Management and Budget fc Suspension or Debarment of the Contractor. The Agency shall send a copy of the petition 5 the Contractor within three (3) working days of filing with the Director. If the Director concludes that the petition has merit, the Director shall schedule and hold a bearing to determine whether to suspend the Contractor, debar the Contractor or deny the petition. The Agency shall have the burden of proving, by a preponderance of the evidence, that the Contractor failed to perform or complete the public works project within the time schedule established by the Agency and failed to do so for one or more of the following reasons: a) failure to supply the adequate labor supply ratio for the project; b) inadequate financial resources; or, c) poor performance on the project. Upon a finding in favor of the Agency, the Director may suspend a Contractor from Bidding on any project funded, in whole or in part, with public funds for up to 1 year for a first offense, up to 3 years for a second offense and permanently debar the Contractor for a third offense. The Director shall issue a written decision and shall send a copy to the Contractor and the Agency. Such decision may be appealed to the Superior Court within thirty (30) days for a review on the record."

8.5 RETAINAGE

- 8.5.1 Per Section 6962(d)(5) a.3, Title 29, Delaware Code: The Agency may at the beginning of each public works project establish a time schedule for the completion of the project. I the project is delayed beyond the completion date due to the Contractor's failure to mee their responsibilities, the Agency may forfeit, at its discretion, all or part of the Contractor's retainage.
- This forfeiture of retainage also applies to the timely completion of the punchlis. A punchlist will only be prepared upon the mutual agreement of the Owner, Architect and Contractor. Once the punchlist is prepared, all three parties will by nutual coefficient, establish a schedule for its completion. Should completion of the punchlist be delayed beyond the established date due to the Contractor's failure to meet the responsibilities, the Agency may hold permanently, at its discretion, all or part of the Contractor's retainage.

ARTICLE 9: PAYMENTS AND COMPLETION

9.1 APPLICATION FOR PAYMENT

- 9.1.1 Applications for payment shall be made upon AIA Document G702. There will be a five percent (5%) retainage on all Contractor's monally invoices until completion of the project. This retainage may become payable upon receipt of all required closeout documentation, provided all other requirements of the contract Documents have been met.
- 9.1.2 A date will be fixed for the taking of the nonthly account of work done. Upon receipt of Contractor's itemized application for payment, such application will be audited, modified, if found necessary, and approved for the amount. Statement shall be submitted to the Owner.
- 9.1.3 Section 6516, Title 29 of the <u>Colaware Code</u> annualized interest is not to exceed 12% per annum beginning thin (30) days after the "presentment" (as opposed to the date) of the invoice.

9.2 PARTIAL PAYYENTS

- 9.2.1 Any public works Contract executed by any Agency may provide for partial payments at the option of the Owner with respect to materials placed along or upon the sites or stored as cured locations, which are suitable for use in the performance of the contract.
- 9.2.2 Wen approved by the agency, partial payment may include the values of tested and acceptable materials of a nonperishable or noncontaminative nature which have been produced or furnished for incorporation as a permanent part of the work yet to be completed, provided acceptable provisions have been made for storage.
- Any allowance made for materials on hand will not exceed the delivered cost of the materials as verified by invoices furnished by the Contractor, nor will it exceed the contract bid price for the material complete in place.
- 9.2.3 If requested by the Agency, receipted bills from all Contractors, Subcontractors, and material, men, etc., for the previous payment must accompany each application for payment. Following such a request, no payment will be made until these receipted bills have been received by the Owner.

9.3	SUBSTANTIAL COMPLETION
9.3.1	When the building has been made suitable for occupancy, but still requires small items c miscellaneous work, the Owner will determine the date when the project has been substantially completed.
9.3.2	If, after the Work has been substantially completed, full completion thereof is notedally delayed through no fault of the Contractor, and without terminating the Contract, the Contract may make payment of the balance due for the portion of the Work fully completed and accepted. Such payment shall be made under the terms and conditions to variing final payment that it shall not constitute a waiver of claims.
9.3.3	On projects where commissioning is included, the commissioning work as defined in the specifications must be complete prior to the issuance of substant. Completion.
9.4	FINAL PAYMENT
9.4.1	Final payment, including the five percent (5%) retainage if Catermined appropriate, shall be made within thirty (30) days after the Work is fully completed and the Contract fully performed and provided that the Contractor has submitted the following closeout documentation (in addition to any other documentation required elsewhere in the Contract Documents):
9.4.1.1	Evidence satisfactory to the Owner trait all payrolls, material bills, and other indebtedness connected with the work have been raid,
9.4.1.2	An acceptable RELEASE (F LIFN)
9.4.1.3	Copies of all applicable wa ranties,
9.4.1.4	As-built drawings,
9.4.1.5	Operations and Maintenance Manuals,
9.4.1.6	Instruction Mar Jals,
9.4.1.7	Concent of Surety to final payment.
9.4.1.8	The Owner reserves the right to retain payments, or parts thereof, for its protection until the foregoing conditions have been complied with, defective work corrected and all unsatisfactory conditions remedied.

ARTICLE 10: PROTECTION OF PERSONS AND PROPERTY

The Contractor shall be responsible for initiating, maintaining, and supervising all safety precautions and programs in connection with the performance of the Contract. The Contractor shall take all reasonable precautions to prevent damage, injury or loss to: workers, persons nearby who may be affected, the Work, materials and equipment to be incorporated, and existing property at the site or adjacent thereto. The Contractor shall give notices and comply with applicable laws ordinances, rules regulations, and lawful orders of public authorities bearing on the safety of persons and property and their protection from injury, damage, or loss. The Contractor shall promptly remedy damage and loss to property

at the site caused in whole or in part by the Contractor, a Subcontractor, or anyone directly or indirectly employed by any of them, or by anyone for whose acts they may be liable.

- The Contractor shall notify the Owner in the event any existing hazardous material such as lead, PCBs, asbestos, etc. is encountered on the project. The Owner will arrange with a qualified specialist for the identification, testing, removal, handling and protection against exposure or environmental pollution, to comply with applicable regulation law, and ordinances. The Contractor and Architect will not be required to participate in or to perform this operation. Upon completion of this work, the Owner will notify the Contractor, and Architect in writing the area has been cleared and approved by the authorities in order for the work to proceed. The Contractor shall attach documentation from the authorities of said approval.
- As required in the Hazardous Chemical Information Act of June 1981 an vendors supplying any materials that may be defined as hazardous, must provide in ceria. Safety Data Sheets for those products. Any chemical product should be considered nazardous if it has a warning caution on the label relating to a potential physical on health hazard, if it is known to be present in the work place, and if employees may be exposed under normal conditions or in any foreseeable emergency situation. Material Said ty Data Sheets must be provided directly to the Owner along with the shipping slips that include those products.
- The Contractor shall certify to the Owner that materials incorporated into the Work are free of all asbestos. This certification may be in the arm of Material Safety Data Sheet (MSDS) provided by the product manufacturer for the materials used in construction, as specified or as provided by the Contractor.

ARTICLE 11: INSURANCE AND BONDS

- The Contractor shall carry air instructions ance required by law, such as Unemployment Insurance, etc. The Contractor shall carry such insurance coverage as they desire on their own property such as a field office, storage sheds or other structures erected upon the project site that belong to them and for their own use. The Subcontractors involved with this project shall carry whatever insurance protection they consider necessary to cover the loss of any of their personal property, etc.
- Upon being awarded the Contract, the Contractor shall obtain a minimum of two (2) copies of all required insurance certificates called for herein, and submit one (1) copy of each certificate, to the Owner, within 20 days of contract award.
- Bodily Injury Liability and Property Damage Liability Insurance shall, in addition to the coverage included herein, include coverage for injury to or destruction of any property arising out of the collapse of or structural injury to any building or structure due to demolition work and evidence of these coverages shall be filed with and approved by the Owner.
 - The Contractor's Property Damage Liability Insurance shall, in addition to the coverage noted herein, include coverage on all real and personal property in their care, custody and control damaged in any way by the Contractor or their Subcontractors during the entire construction period on this project.
- Builders Risk (including Standard Extended Coverage Insurance) on the existing building during the entire construction period, shall not be provided by the Contractor under this contract. The Owner shall insure the existing building and all of its contents and all this new alteration work under this contract during entire construction period for the full insurable value of the entire work at the site. Note, however, that the Contractor and their

Subcontractors shall be responsible for insuring building materials (installed and stored) and their tools and equipment whenever in use on the project, against fire damage, theft, vandalism, etc.

- 11.6 Certificates of the insurance company or companies stating the amount and type of coverage, terms of policies, etc., shall be furnished to the Owner, within 20 days of contract award.
- 11.7 The Contractor shall, at their own expense, (in addition to the above) carry the following forms of insurance.

- 11.7.4 Pr me Contractor's and Subcontractors' policies shall include contingent and contractual liability coverage in the same minimum amounts as 11.7.1 above.
- 11.7.5 Workmen's Compensation (including Employer's Liability):
- 11., 5.1 Minimum Limit on employer's liability to be as required by law.
- 11.7.5.2 Minimum Limit for all employees working at one site.
- 11.7.6 Certificates of Insurance must be filed with the Owner <u>guaranteeing</u> fifteen (15) days prior notice of cancellation, non-renewal, or any change in coverages and limits of liability shown as included on certificates.

11.7.7 Social Security Liability

- With respect to all persons at any time employed by or on the payroll of the Contractor or performing any work for or on their behalf, or in connection with or arising out of the Contractor's business, the Contractor shall accept full and exclusive liability for the paymen of any and all contributions or taxes or unemployment insurance, or old age retirement benefits, pensions or annuities now or hereafter imposed by the Government of the lineal States and the State or political subdivision thereof, whether the same be measured by wages, salaries or other remuneration paid to such persons or otherwise.
- Upon request, the Contractor shall furnish Owner such information on pryrolls or employment records as may be necessary to enable it to fully comply with the law imposing the aforesaid contributions or taxes.
- 11.7.7.3 If the Owner is required by law to and does pay any and/or all or "le a presaid contributions or taxes, the Contractor shall forthwith reimburse the Owner for the contractor shall by the Owner.

ARTICLE 12: UNCOVERING AND CORRECTION OF WORK

- The Contractor shall promptly correct Work rejected by the Owner or failing to conform to the requirements of the Contract Documents, whicher observed before or after Substantial Completion and whether or not fabricated, inscalled or completed, and shall correct any Work found to be not in accordance with the requirements of the Contract Documents within a period of two years from the date of Substantial Completion, or by terms of an applicable special warranty required by the Contract Documents. The provisions of this Article apply to work done by Subcontractors of well as to Work done by direct employees of the Contractor.
- At any time during the progress of the work, or in any case where the nature of the defects shall be such that it is not expedient to have them corrected, the Owner, at their option, shall have the right to deduct such sum, or sums, of money from the amount of the contract as they consider justified to adjust the difference in value between the defective work and that required under contract including any damage to the structure.

ARTICLE 13: MISCELLA' EO'S PROVISIONS

- 13.1 CONTING AND PATCHING
- 13.1.1 The Contractor shall be responsible for all cutting and patching. The Contractor shall coordinate the work of the various trades involved.
- 3.2 DIMENSIONS
 - All dimensions shown shall be verified by the Contractor by actual measurements at the project site. Any discrepancies between the drawings and specifications and the existing conditions shall be referred to the Owner for adjustment before any work affected thereby has been performed.

13.3 LABORATORY TESTS

- Any specified laboratory tests of material and finished articles to be incorporated in the work shall be made by bureaus, laboratories or agencies approved by the Owner and reports c such tests shall be submitted to the Owner. The cost of the testing shall be paid for by the Contractor.
- The Contractor shall furnish all sample materials required for these tests and shall deliver same without charge to the testing laboratory or other designated agency when and where directed by the Owner.

13.4 ARCHAEOLOGICAL EVIDENCE

Whenever, in the course of construction, any archaeological evidence is an countered on the surface or below the surface of the ground, the Contractor shall putify the authorities of the Delaware Archaeological Board and suspend work in the immediate area for a reasonable time to permit those authorities, or persons designated by them, to examine the area and ensure the proper removal of the archaeological evidence for suitable preservation in the State Museum.

13.5 GLASS REPLACEMENT AND CLEANING

The General Contractor shall replace without ex, ense to the Owner all glass broken during the construction of the project. If job randitans warrant, at completion of the job the General Contractor shall have all glass cleaned and radiations.

13.6 WARRANTY

For a period of two (2) years from the date of substantial completion, as evidenced by the date of final acceptance on the work, the contractor warrants that work performed under this contract conforms to the contract requirements and is free of any defect of equipment, material or workmanship performed by the contractor or any of his subcontractors or suppliers. However, manufacturer's warranties and guarantees, if for a period longer than two (2) years, shall take precedence over the above warranties. The contractor shall remedy at hoow, expense, any such failure to conform or any such defect. The protection of this war, anty shall be included in the Contractor's Performance Bond.

ARTICLE 14: TERN'INATION OF CONTRACT

If the Contractor defaults or persistently fails or neglects to carry out the Work in accordance with the Contract Documents or fails to perform a provision of the Contract, the Owner, after seven days written notice to the Contractor, may make good such deficiencies and may deduct the cost thereof from the payment then or thereafter due the Contractor. Alternatively, at the Owner's option, and the Owner may terminate the Contract and take possession of the site and of all materials, equipment, tools, and machinery thereon owned by the Contractor and may finish the Work by whatever method the Owner may deem expedient. If the costs of finishing the Work exceed any unpaid compensation due the Contractor, the Contractor shall pay the difference to the Owner.

"If the continuation of this Agreement is contingent upon the appropriation of adequate state, or federal funds, this Agreement may be terminated on the date beginning on the first fiscal year for which funds are not appropriated or at the exhaustion of the appropriation. The Owner may terminate this Agreement by providing written notice to the parties of such non-appropriation. All payment obligations of the Owner will cease

upon the date of termination. Notwithstanding the foregoing, the Owner agrees that it will use its best efforts to obtain approval of necessary funds to continue the Agreement by taking appropriate action to request adequate funds to continue the Agreement."

Section 011700 SUPPLEMENTARY ROOFING CONDITIONS

1.0 Description

The work consists of furnishing and installing all roofing and related items as specified and diagrammed herein.

2.0 Concurrent Operations

Because other activities of the Northeast State Service Center will be proceeding at the same time as the work covered by these specifications, the contracter sham cooperate with the State of Delaware (State) Administrator to insure that all contract work progresses in a manner that does not conflict with other activities of the Northeast State Service Center. Set up areas will be designated at the pre-bid meeting.

3.0 Workmanship

All workmen shall be certified in the particular trade an Vor class in which they are employed. All work shall be done according to the specifications covering the class or type of work and shall meet the approval, in the field, of the State Administrator. The contractor's representative or job super isor shall have a complete copy of the specifications on the job site at all time. Any questions not covered in the method specifications shall be resolved at dapproved in writing by the State and the State's Technical Representative.

4.0 Number of Crews Ca-Site

In order that the work may be accomplished in the shortest possible time, the successful bidder, weather permitting, shall be required to have at least one crew of six (6) qualified personnel with its' own responsible foreman, at work on-site at all times. This seven (7) man crew shall remain on-site throughout the duration of the successful bidder's work. At no time shall less than this crew be at work without the express consent of the State Administrator will be advised of changes in supervision.

<u> 7 0 Storage of Materials</u>

All materials shall be stored on-site at a place designated by the State Administrator. No materials shall be removed from the job site by the contractor for any reason, except where specifically authorized, in writing, by the State Administrator. All materials shall be inventoried as soon as possible after delivery as possible by the State Administrator and the contractor. Any items lost or stolen as a result of not being secured shall be the responsibility of the contractor to replace. All roofing felts, insulation and other absorbent roof material components must be maintained in dry condition.

ALL WET OR DAMP MATERIALS SHALL BE REMOVED from the job site and replaced with dry materials. Contractor shall be responsible for providing dry storage. **Tarpaulins** will be required for protection of all roof insulation. All plastic shipping wrappings will be removed from insulation prior to storage.

All equipment stored on the ground must be protected by a temporary fence or other approved structure.

6.0 Decks

Situations will develop where deck repair and deck replacement will be required. Contractor will include with all bids, a unit price for deck repair and a init price for deck replacement.

7.0 Drains

Situations will develop where additional drainage is required. Contractors will include with all bids, a unit price for new installed drain assembly.

8.0 Insulation

Insulation shall have accurate dimensional stability so as to properly conform to the surfaces of the roof, cants, curbs, pipes, it. Joints between boards shall be tight and insulation shall be held back 1/8 including varical surfaces and sumps. INSULATION SHALL BE PROTECTED FROM THE WEATHER AT ALL TIMES.

9.0 Compliance

Non-compliance with the terms of this specification and ensuing contract can result in either cancellation of the contract or in complete reworking or replacement of defective areas at the contractor expense. In the event of cancellation, the State shall not be obligated to compensate the contractor for any work, or any roof installed in a defective manner, or which fails to meet the specification criteria.

Furtherness, DAMAGE CAUSED BY WATER INFILTRATION RESULTING From: THE FAILURE OF THE CONTRACTOR TO SECURE EACH DAY'S WORK IN A WATERTIGHT MANNER WILL BE CORRECTED AT THE CONTRACTOR'S EXPENSE. INCLUDED, AS DAMAGES WILL BE ALL LABOR COSTS INCURRED BY THE STATE AS A RESULT OF SUCH WATER INFILTRATION.

The standard of all work shall be to the specification of the State Administrator. In the event of non-compliance or substandard or defective work, the State Administrator or the delegated representative may, at his discretion, halt further work until discrepancies are rectified at the contractor's expense. The State Administrator and the State's Technical Representative shall be the final authority in the interpretation of all specifications contained herein. **The roofing segment of work will not be subcontracted.**

10.0 Protection of Roof Membrane

Roof traffic is to be confined to the actual work area to the greatest extent possible. Where hauling over other areas is necessary, the roof will be protected with ply wood. Contractor shall be responsible for repairs and leaks in traffic areas acring and after the job.

11.0 Job Conditions

All surfaces to be treated shall be smooth, visually dry, and free from dirt, debris and foreign matter before any treatment is initiated. Weather temperatures will be a minimum of 40 degrees F. and rising during roofing operations, and protective tarpaulins will be available for emergency protection of roo. work in progress during periods of changing weather. THE STANDARD OF SURFACE CLEANLINESS SHALL BE TO THE SATISFACTION OF THE STATE ADMINISTRATOR AND/OR STATE'S REPRESENTATIVE.

The Contractor is responsible to put up the existing and/or new roof in order to provide a suitable environment for roofing to proceed. Contractor shall include in his/her base bid all necessary costs associated with pumping of roof.

The contractor shall be a sponsible for exercising all reasonable precautions to avoid fires being started, and shall provide suitable fire extinguishers located where they can be promptly used when needed. Competent operators shall be in attendance at all times when equipment is in use. Materials and equipment shall be stored neatly in areas designated by the State Administrator, and dispersed so as to insure a minimum fire hazard

Laa placed on the roof at any point shall not exceed the safe loading for which the roof was designed.

Tarpaulins will be used to cover sides of building at all loading and chute locations.

12.0 Clean-Up

Roof drains, gutters, scuppers and downspouts, must be kept clean and free from debris and obstructions, and must be functional during the project and at the completion of the project. The job foreman shall be responsible for daily inspection of work area to assure that no floatable trash or materials are left to clog drains. **DRAINAGE MUST BE FREF FLOWING AT ALL TIMES.**

All other accumulating debris shall be removed daily to assure maximum safety and sanitation at all times. At completion of all work, the contractor shall remove excess materials and debris from the site and leave roof surfaces and work site free from accumulations of spoil, debris and other extraneous materials from wirelyws, floors, walls, ladders and other finished surfaces. Any damage to buildings or grounds caused by the contractor shall be rectified at the contractor's expense to the satisfaction of the State Administrator before final payment is made. Equipment and tools must meet OSHA and the State requirements. Barricades with tags will be installed as equired by the State.

13.0 Temporary Electrical Power

The electrical power at the existing building will be available to the contractor. Cost of electricity will be paid for by the State.

14.0 Temporary Water

The water at the existing building vill be available to the contractor. Cost of water will be paid for by the State.

15.0 Inspection of Wor's in Progress and Upon Completion

It shall be the responsionity of the Contractor to arrange an inspection of the job site with the State Administrator, State's Technical Consultant, and the Materials Manufacturer's Field Representative at the following times:

- Prior to start of work. Conditions at the time shall be noted. All necessary work permits must be obtained before work begins.
- 2. PRIOR TO FINAL FINISH TO THE APPLIED ROOF SYSTEM.

16.0 Core Samples

During application or upon completion, the State reserves the right to test materials and extract cores, within reason. Deficiencies will be considered less than the scope of the specification and payment will be withheld until proper corrections have been done.

17.0 Final Inspection

The representative of the contracting firm shall notify the State Administrator when he is within five (5) working days of completing a particular project. A final inspection team consisting of the State Administrator, the State's Technical Representative, the Representative of the Contracting Firm, the Contractor's Job Foreman, and Materials Manufacturer's Field Representative, shall inspect the work. Any defects noted in the work during the course of this final inspection shall be corrected to the satisfaction of the State Administrator WITHIN 15 DAYS and prior to the removal of the contractor's equipment from the job site.

18.0 Final Payment

Retainage throughout the contract period will be ten (10) percent. Final syment including the 10% retainage will not be approved until all pur in list items are addressed and the warranty is delivered to the client and accepted.

20.0 Insurance

21.0 Progress of World

Part 1 – GENERAL:

1.1 SUMMARY:

A. Section includes: Administrative and procedural requirements for construction waste management activities.

1.2 DEFINITIONS:

- A. Construction, Demolition, and Land clearing (CDL) Waster Includes all non-hazardous solid wastes resulting from construction, removeling, alternations, repair, demolition and land clearing. Lich des material that is recycled, reused, salvaged or disposed as garbage.
- B. Salvage: Recovery of materials for on-site it use, sale or donation to a third party.
- C. Reuse: Making use of a material without altering its form. Materials can be reused on-site or reused on cheapprojects off-site. Examples include, but are not limited to the following: Crushing or grinding of concrete for use as sub-base materials. Chipping of area clearing debris for use as mulch.
- D. Recycling: The process of sorting, cleaning, treating, and reconstituting materials for the purpose *c*. using the material in the manufacture of a new product.
- E. Source separated CDL Recycling: The process of separating recyclable materials in reparate containers as they are generated on the job-site. The separated materials are hauled directly to a recycling facility or transfer station.

 - 1. Types of estimated quantities, by weight, of CDL waste expected to be generated during demolition and construction.
 - 2. Proposed methods for CDL waste salvage, reuse, recycling and disposal during demolition including, but not limited to, one of more of the following:
 - a. Contracting with a deconstruction special of the salvage materials generated,
 - b. Selective salvage as part of demolnion contractor's work,
 - c. Reuse of materials on-site or ale or anation to a third party.
 - 3. Proposed methods for salvage, reuse, recycling and disposal during construction including, but not haited to, one or more of the following:
 - a. Requiring subcontractors to take their CDL waste to a recycling facility.
 - b. Contracting with a recycling hauler to haul recyclable CDL waste to an approved recycling or material recovery facility; c. Processing and reusing materials on-site;
 - a. Self-hauling to a recycling or material recovery facility.
 - 4. Name of recycling or material recovery facility receiving the CDL wastes.
 - 5. Handling and Transportation Procedures: Include method that will be used for separating recyclable waste including sizes of containers, container labeling, and designated location on project site where materials separation will be located.
- D. Cost/Revenue Analysis: Indicate total cost of waste disposal as if there was no waste management plan and net additional cost or net savings resulting from implementing waste management plan. Include the following:
 - 1. Total quantity of waste.
 - 2. Estimated cost of disposal (cost per unit). Include hauling and tipping fees and cost of collection containers for each type of waste.

- 3. Total cost of disposal (with no waste management).
- 4. Revenue from salvaged materials.
- 5. Revenue from recycled materials.
- 6. Savings in hauling and tipping fees by donating materials.
- 7. Savings in hauling and tipping fees that are avoided.
- 8. Handling and transportation cost. Including cost of collection containers for each type of waste.
- 9. Net additional cost or net savings from waste management plan.

Part 3 - EXECUTION:

3.1 CONSTRUCTION WASTE MANAGEMENT, GENERAL:

- A. Provide containers for CDL waste that is to be review clearly labeled as such with a list of acceptable and unacceptable materials. This list of acceptable materials must be the same as the pater als recycled at the receiving materials recovery facility or reveling processor.
- B. The collection containers for recyclable CDL waste must contain no more that 10% non-recyclable material, by volume.
- C. Provide containers for CDL wester that is disposed in a landfill clearly labeled as such.
- D. Use detailed material estimates to reduce risk of unplanned and potentially wast sful cuts.
- E. To the createst extent possible, include in material purchasing agreements a waste reduction provision requesting that materials and equipment be delivered in packaging made of recyclable material, that they reduce the amount of packaging, that packaging be taken back for reuse or recycling, and to take back all unused product. Insure that subcontractors require the same provisions in their purchase agreements.
- F. Conduct regular visual inspections of dumpsters and recycling bins to remove contaminants.

3.2 SOURCE SEPARATION:

A. General: Contractor shall separate recyclable materials from CDL waste to the maximum extent possible.

Separate recyclable materials by type.

- 1. Provide containers, clearly labeled, by type of separated materials or provide other storage method for managing recyclable materials until they are removed from Project site.
- 2. Stockpile processed materials on-site without intermixing with other materials. Place, grade, and shape stockpiles to drain surface water and to minimize pest attraction. Cover to prevent wind olow dust.
- 3. Stockpile materials away from demolition area. Do not stor with drip line of remaining trees.
- 4. Store components off the ground and protect from coacher.

3.3 CO-MINDGLED RECYCLING:

A. General: Do not put CDL waste that will be disposed in a landfill into a comingled CDL waste recycling container.

3.4 REMOVAL OF CONSTRUCTION WASTE MATER. ALS:

- A. Remove CDL waste materials from project site on a regular basis. Do not allow CDL waste to accumulate or -site.
- B. Transport CDL waste materials of Owner's property and legally dispose of them.
- C. Burning of CDL waste i. not permitted.
