

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MJ3514000019 – Delaware Hospital for the Chronically Ill – Powerhouse/Laundry/Garage Building – Roof Restoration and Repair** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Tuesday, June 6, 2017, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the following at the Powerhouse/Laundry/Garage Building at the Delaware Hospital for the Chronically Ill in Smyrna, Delaware: general repairs to the existing single ply roofing systems, powerwashing the membrane, priming and installing a reinforced EnergyStar rated coating system. Project also includes repair and waterproofing of selected masonry walls and concrete coping stones along with repairs to the asphalt shingle roofs.
