

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MJ3514000022 – Delaware Hospital for the Chronically Ill – Candee Building – Roof Repair and Restoration** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 1:30 p.m. local time on Tuesday, August 7, 2018, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

The project involves the following at the Candee Building at the Delaware Hospital for the Chronically Ill in Smyrna, Delaware: general repairs to the existing single ply roofing system and repair to the existing gutter and downspouts where required, as well as repair and waterproofing of selected masonry walls. Project also includes an add alternate for powerwashing the membrane, priming and installing a reinforced EnergyStar rated coating system.

A **MANDATORY** Pre-Bid Meeting will be held on Friday, July 20, 2018, at 9:00 a.m. in the Facilities Office of the Delaware Hospital for the Chronically Ill, 100 Sunnyside Road, Smyrna, Delaware, for the purpose of establishing the list of subcontractors and to answer questions.
