

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MJ3701000003 – Murphy House Annex – Roof Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Wednesday, June 28, 2017, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves replacement of the existing shingle and single ply roof systems at the Murphy House Annex located on the Ferris Detention Center Campus, 1825 Faulkland Road, Wilmington, Delaware. Project also includes repair and waterproofing of selected masonry chimneys.
