

**ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MJ3705000005 – Terry Children’s Center – Bathroom Renovations – Re-Bid** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 1:00 p.m. local time on Monday, March 13, 2017, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project includes, but is not limited to, the following at the Terry Children’s Center located in New Castle, Delaware: demolition of existing toilet fixtures, interior partitions and supply and waste piping and vents as well as selected heating and ventilation systems; selective demolition of walls, floors, floor finishes, wall finishes, doors and frames in selected areas; installation of new toilet fixtures, sinks and toilet partitions; installation of new masonry or metal stud walls where shown; installation of new lighting, heating and exhaust systems; installation of new epoxy resinous floor systems.

A **MANDATORY** Pre-Bid Meeting will be held on Wednesday, February 22, 2017, at 10:00 a.m. at the Terry Children’s Center, 10 Central Avenue, New Castle, Delaware, for the purpose of establishing the list of subcontractors and to answer questions.
