Sealed bids for **OMB/DFM Contract No. MJ3804000008 – James T. Vaughn Correctional Center – Building “D” – Roof Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, Delaware 19901 until 1:00 p.m. local time on Thursday, July 19, 2012, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

A **MANDATORY** Pre-Bid Meeting will be held on Monday, July 2, 2012, at 11:00 a.m. in the conference room of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Third Floor, Dover, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**
