Sealed bids for **OMB/DFM Contract No. MJ3804000021 – Vaughn Correctional Center – Building “K” – Roof Repair** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Thursday, March 24, 2016, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project consists of the following at the James T. Vaughn Correctional Center located in Smyrna, Delaware: roof restoration to extend its useful life; remove and replace wet insulation; repair gouges in membrane and repair open flashings; power wash and install reinforced white urethane coating; approximate area of 13,524 s.f.
