Sealed bids for **OMB/DFM Contract No. MJ3804000089 – Sussex Correctional Institution – Tower 5 Deck Roof Replacement – Re-Bid** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Friday, July 29, 2016, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project consists of repair of the observation walkway area of Tower 5 at the Sussex Correctional Institution located in Georgetown, Delaware. This area has pavers over a roof membrane. The existing roofing system, roof drains and pavers are to be removed and replaced with a new roofing system and drains. Pavers to be reused except at roof drain locations where new pavers will be required. Installation of new roof scuppers is also included.

A **MANDATORY** Pre-Bid Meeting will be held on Thursday, July 14, 2016, at 10:00 a.m. at the Sussex Correctional Institution, 23203 DuPont Boulevard, Georgetown, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**
