Sealed bids for **OMB/DFM Contract No. MJ3804000092 – Sussex Correctional Institution – Minimum Security Building - Roof Replacement – Re-Bid** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 1:30 p.m. local time on Thursday, March 29, 2018, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves removal of the existing shingle roofing system in its entirety, installing a new shingle roofing system on new plywood decking, and repointing the existing masonry chimney of the Minimum Security Building at the Sussex Correctional Institution located in Georgetown, Delaware.

A **MANDATORY** Pre-Bid Meeting will be held on Monday, March 5, 2018, at 10:00 a.m. in the Facilities Management Conference Room on the Third Floor of the Thomas Collins Building, 540 S. DuPont Highway, Dover, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**

Site visits will be scheduled separate from the pre-bid meeting. A security (background) clearance is required of all approved attendees intending to visit the site on the pre-selected date(s). Security Clearance forms will be handed out at the pre-bid meeting.
