GENERAL CLARIFICATIONS:

- Revision: Attached to this addendum is revised sheet CC-04 Overall Site Plan and Laydown 1. Area dated 8/29/18. All work associated with this revised plan shall be part of Contract **JTVCC-001**.
- 2. All work associated with the demolition and removal of the covered walkway indicated on Sheet CC-05 of the contract documents shall be deleted from the scope of work for Contract JTVCC-001.
- 3. Revision: Attached to this addendum is a revised sheet CC-06 Lines and Grades Plan dated 8/29/18. All work associated with this revised plan shall be part of Contract JTVCC-001.
- 4. Clarification: any new openings created by this contract in the existing buildings or existing fences/gates must be secured each day. EDiS and the DOC shall be notified 48 hours in advance of any tie in work occurring.
- 5. Clarification: the approximate flow rate of the sanitary sewer for the existing building is as follows.
 - 0.1 GPD/S.F. X 11,760 S.F. = 1,176 GPD
- 6. The temporary access road shall be removed by Contract JTVCC-001 as currently scoped.
- 7. The two lined ballast stone areas shall be removed by Contract JTVCC-001 as currently scoped.
