

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MJ3804000099 – Vaughn Correctional Center – “C” Building – Demolition** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Thursday, November 14, 2019, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the full demolition of the existing “C” Building at James T. Vaughn Correctional Center (JTVCC) in Smyrna, Delaware. “C” Building is a 12,700 square foot single story, with basement, masonry building within the secure perimeter of JTVCC. Building site will be restored to a field and seeded with grass.

A **MANDATORY** Pre-Bid Meeting will be held on Monday, October 21, 2019, at 9:00 a.m. in the Facilities Management conference room in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representative of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**

Site visits will be scheduled separate from the pre-bid meeting. A security (background) clearance is required of all approved attendees intending to visit the site on the pre-selected date(s). Security Clearance forms will be handed out at the pre-bid meeting.

Sealed bids shall be addressed to the Division of Facilities Management, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901.
