

## ADVERTISEMENT FOR BID

Sealed bids for **OMB/DFM Contract Nos. MJ3806000001/MJ3806000002/MJ3806000004 – Plummer Community Corrections Center - Roof Replacements** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Thursday, January 7, 2016, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves removal of existing shingle roof system at the Rhodes Building and sections of the Crest Building and Maintenance Building of the Plummer Community Corrections Center including repairs to existing roof deck; installation of new shingle roof system; approximate shingle roof area is 5,135 s.f. Also included is the removal of the existing flat roofing systems on the Maintenance Building and portions of the Crest Building; installation of new SBS modified bitumen roofing system; approximate SBS modified bitumen roofing area is 5,765 s.f.

A **MANDATORY** Pre-Bid Meeting will be held on Thursday, December 3, 2015, at 10:00 a.m. in the Facilities Management conference room in the Thomas Collins Building, 540 S. DuPont Highway, Third Floor, Dover, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**

Site visits will be scheduled separate from the Pre-Bid Meeting. A security (background) clearance is required of all approved attendees intending to visit the site on the pre-selected date(s). Security Clearance forms will be handed out at the Pre-Bid Meeting.
