2.a	BMG introduces the Project Team. Becker Morgan Group, Inc. (BMG) is the Architect and Civil Engineer for the project. Overall project manager for Becker Morgan Group, Inc. is Brenden Frederick, AIA, LEED AP BD+C. Principal in charge of the project is Gregory Moore, P.E. MEP Engineer is Delaware Engineering Design Co. (DEDC). Structural Engineer is Baker, Ingram & Associates. (BIA)
2.b.	Owner's Team is comprised of the Delaware State Police and the Division of Facilities Management. Representing the state are Larry Schrock (DFM) and William Braswell (DSP).

4.a.	Project Overview: This overall project includes approximately 32,000 sq. ft. Troop Facility, 10,114 sq. ft. Maintenance Facility, and associated site work.
4.b	Water is currently not available onsite. Dixie Construction has been awarded contract to complete this work, however construction has not started. Project Team will identify when that work is expected to be completed and have Contractor provide an allowance if that date is exceeded, and issue via addendum.
4.c	Project Scope includes installation of fuel tank and associated conduits, as noted within the documents. The Owner will award a contract for the remainder of fuel system; refer to Division 01 Specifications for additional information.
4.d	The rear access to tie into the future roadwork, being completed by Developer of adjacent parcel. Site Contractor to coordinate accordingly.
4.e	Maintenance Building: Contractor includes (1) new lift to be provided and installed by Contractor. There are (2) lifts being provided by the Owner to be installed by the Contractor; refer to Division 01 Specifications for additional information.
4.f.	Substantial Completion: Contractor to identify number for calendar days to complete the work from the Notice to Proceed on the Bid Form. Anticipate Purchase Order for construction to be released to Contractor by Mid-August 2018.

- i. Question: Has the Owner contracted with a commission agent?

 Response: Yes, the Owner has hired a third party commissioning agent.
- ii. Question: Is the Mechanical Contractor responsible for Testing and Balancing?

 Response: The State is in negotiations with a State contract award for Testing and
 Balancing, that if confirmed, would change the responsibility of Testing and Balancing to the
 Owner. This will be clarified via addendum.
- iii. Question: Has the project received permits?

Response: The site permits have been received. The Building Permit is in process and the documents are being sent to the Delaware State Fire Marshal by the Design Team concurrently with bidding. Permit costs associated with the building permit (Fire Marshal / Sussex County) will be paid by the Owner. All other construction permits will be the responsibility of the respective Contractor(s).

- iv. Question: Requirements for Security / Access control scope?

 Response: This will be clarified via addendum when the Security / Access Drawings and Specifications are issued.
- v. Question: What is the project scope, if Alternate # 1 is not accepted? Response: This will be clarified via addendum.
- vi. Question: How far does the electric utility extend?

 Response: This will be clarified in addendum, as the State is in negotiations with the adjacent parcel Owner for an alternate path.
- vii. Question: Is data cabling a part of the contract or being provided by Owner's Contractors? Response: The data cabling is part of contract documents; DTI will be providing the technology equipment. Refer to the Drawings / Specifications for additional information.
- viii. Question: Who is responsible for CCR reports?

 Response: The Contractor is responsible for all CCR requirements.
