To all prospective bidders under the specifications and contract documents described above, this Addendum to RFP is being issued to answer the following submitted questions:

1. When quoting an hourly rate should this include travel time or exclude and bill travel separately?

Travel time should be included in hourly rates as it will not be billed/paid separately by the District.

2. Will the District allow use of both Licensed Therapists and Therapy Assistants (i.e. COTA or PTA) or are we required to only use Licensed Therapists?

You can provide quotes for each one but the District would prefer licensed therapists.

3. We would like to bid on all services, however, we are concerned that the short time span between acceptance of a bid and start of the contract may not allow time to find and hire specialty staff , (i.e SLPs who are bilingual or certified for assistive technology evals). Would we be allowed to start with PT, OT and 2 general SLP's and hire Specialty SLPs as soon as possible? This may be a moot point if we could find specialty SLP's quickly but we wanted to see if this would be acceptable to the District if the need arose.

Please just indicate any exceptions in your bid response.

4. What is the anticipated date of award and how will vendors be notified?

ASAP – most likely on August 16th at the District's August board meeting. All vendors will receive a letter in the mail
