1. I am just confirming that prevailing wage rates applies to this work and I should quote labor based on prevailing wage?

They may apply depending on the size of the job.

2. Please clarify the quantities for each of the cameras, NVR's, PoE's, cable runs etc.

Please provide price on 1-10 units and price on 10-50 units

3. Please clarify the frame rate and resolution for all NVR's – we need this to calculate storage size to meet your 30-day recording requirement.

Frame rate and resolution to be determined by what IP cameras are used and the number of IP cameras that will be used on each NVR. That's why the NVRs are quoted with 0TB storage and the Storage amount will be added after RFP is opened and camera amounts are determined

4. Please clarify the quantities of all cameras for the buses. If the total quantity is not known then please provide an estimate of how many and how many deployed per month/quarter or year?

Please provide price on 1-10 units and price on 10-50 units

5. Please provide the locations of all cameras, NVR's, PoE's and any and all hardware to be installed?

6. Please advise if the NVR's as well as PoE's are going into equipment closets, racks, data centers? If not what is the environment for such and will power be provided?

9. Please advise if wire mold/surface mounting is acceptable for all cameras and POE equipment or if in ceilings, walls, floors please provide sections and elevation drawings so we can calculate labor and materials.

10. Under evaluation criteria please advise is our experience as federal contractors doing the same work (256 cameras installed for USAF, San Antonio, TX able to receive the same weighting consideration as work for DE and DE school systems?

We would like to use local vendors with service office in Delaware for quicker service. We want vendors with experience with working with Delaware schools only for evaluation.

11. On page 11 the requirement is for “ b) Medical/Professional Liability \$1,000,000/ \$3,000,000 “
a. Is this a cut and paste error? We are not providing any professional medical services.

We would require professional liability insurance.

12. Page 13 item 27 states “Before submitting proposal, bidders shall fully inform themselves of the nature of the work by personal examination of the site, and by such means as they consider necessary”

a. However Page 19 states “Site Inspection There will be NO PRE-BID MEETING.”

b. Please advise as to which has precedent the statement on page 13 item 27 or that there is no required site visit and inspection of premises?

There will be no pre-bid meeting.

13. Page 18 states the start of installation as June 1 2018 and continuing until June 1, 2020.

a. Please advise the start date and end date (since June 1st has past)

The start date will be once the contract is awarded by the District's board of education and end date will be June 1, 2020.
