

## Addendum No. 1 / Pre-Bid Meeting Minutes

Red Clay Consolidated School District H. B. DuPont Middle School Pavement Improvements Contract # RCCD21050-PAVEMENT

## This Addendum No. 1 becomes part of the Contract Documents. Please acknowledge receipt of this Addendum in the space provided on Page 2 of the Bid Form.

A mandatory Pre-Bid Meeting was held on July 14, 2020, for the proposed Pavement Improvements at H. B. DuPont Middle School located at 735 Meeting House Rd, Hockessin, DE 19707. The following items were discussed and should be considered in the preparation of bids for the project.

- 1. A summary of the overall project scope was provided and the anticipated project scheduled was discussed. Questions were received and then the attendees were invited to walk the site.
- 2. Based on the questions asked during the pre-bid meeting, the following modifications / clarifications to the bid documents shall be considered in preparation of a bid:
  - a. Work performed during the school year (beginning August 24, 2020) shall be performed during the hours of 6:00 PM through 6:00 AM. The bid form has been revised to provide two base bids:
    - i. Base Bid No. 1: the work shall be completed prior to August 24, 2020,
    - ii. Base Bid No. 2: the work may be completed after August 24, 2020.

The contractor may elect to bid on both base bids or select one of the two. In order for the bid to be considered complete, the letters "NA" must be written inplace of a lump-sum fee if the Contractor chooses not to bid on that base bid.

- b. Existing bumper blocks are to be reinstalled after pavement work is completed to match existing conditions. Bumper blocks damaged by the Contractor during moving and reinstallation are to be replaced at no cost. Where existing bumper blocks are broken, RCCSD will provide replacement bumper blocks.
- c. All pavement markings shall be performed using parking lot grade acrylic waterborne striping paint. Sheet 2 – Details and Notes has been updated to reflect this requirement.



- d. A minimum of one (1) apprentice per employer is required. Subcontractors are not required to have an apprentice program.
- e. Pavement improvements shall extend up to the fence surrounding the electrical transformer box.
- f. Pavement improvements shall stop just prior to the existing painted walkways at the two entrances. Repainting of the crosswalks at the entrances is not required.
- g. The 4" Perforated Pipe Underdrain Detail will not be utilized.

The last date for submission of questions is Thursday, July 23, 2020 at 5:00 pm. The last addendum will be issued by 5:00 pm on Friday July 24, 2020.
- 4. Bids are due on Wednesday, July 29, 2020 at 1:30 pm. Bids should be submitted to the Red Clay Consolidated School District, Facilities Department, 1798 Limestone Road, Wilmington, DE 19804. To attend the bid opening, Contractors should report to the Stanton Middle School Main Office, located at 1800 Limestone Rd, Wilmington, DE 19804.
