Original text of Request For Information (RFI)

In an effort to assist its law enforcement community in making educated and informed purchasing decisions, the Delaware Office of Highway Safety is requesting information on speed enforcement products such as radar and laser and accessories for same.

Requested information should include types of speed enforcement products, their technical specifications and pricing. Information packets may consist of the vendor's catalog or other standard product literature. Vendors who wish to have this information shared with State, County and municipal law enforcement agencies in the State of Delaware should submit the information by **Friday November 5, 2010 at 12 noon** to the attention of the following:

Additionally, the Office of Highway Safety will provide the opportunity for vendors to demonstrate their products to law enforcement on **Wednesday November 17, 2010 at 10 a.m. on the access road between the Dover Rt. 1 Toll Plaza and Dover International Speedway in Dover, Delaware.** For directions on how to reach this location, please contact Lt. Please be aware that the Office of Highway Safety itself will not use the demonstration to make any purchasing decisions of its own and is merely coordinating the demonstration for law enforcement across the state. However, law enforcement agencies statewide that come to view this demonstration *may* use the information to make decisions regarding purchasing equipment for their agency.

Vendors who wish to take advantage of this opportunity to demonstrate their products should come with the equipment already mounted in the vehicle they bring (if the equipment requires mounting) and bring all necessary accessories. They should bring whatever radar and laser equipment to demo that they feel an agency should see when considering their options. They should also be prepared to answer any questions from law enforcement officers. No reimbursement for travel expenses will be provided for vendors to participate in this demonstration of their products which will involve active use of the equipment to detect the speed of moving vehicles.
