Alison,

I looked up your RFP information and based on the following information, it appears that you have the opportunity to renew for up to six (6) years in incremental periods:

SHS-11-006-PubRelatns

D. Contract Terms and Conditions; 1. General Information

a. The term of the contract between the successful bidder and the State shall be for one (1) year reimbursable contract period from October 1, 2011 and September 30, 2012. Each contract may be renewed for up to six (6) years in one (1) or two (2) year periods.

You will have to confirm your use of your renewal periods for me, but it appears that you have utilized two (2) renewal years already. If this is the case, I recommend that your group renew for one (1) additional year as we transition into the new contract vs. engaging in month-to-month agreements. First, month-to-month is not in your contract and also, by going with a one (1) year option ... that will give you a good opportunity at looking at transitioning to the new contract when your extension is up.

I also recommend that about 2-3 months out from extension expiration, you send job scope packages out to the vendors on contract so you can get some pricing nailed down from the vendors on contract. If AB&C is on or not...this will give you a good opportunity to price check and evaluate your needs under the new contract.

If you have any additional questions, just let me know...it really is dependent upon your renewal period your currently in...so if you confirm that and you're in year 2 of the extension, then I would support recommending DSHS in one additional year to let the new contract get rolling and then give you adequate time for transitioning.


