1.0 CLARIFICATIONS TO PRE-BID INFORMATION/AGENDA

- 1.1 Project will be constructed under a single prime contract with a **Roofing Contractor or a General Contractor**.
- 1.2 Walkthrough dates and times are as requested: Contact Kenneth Starke at kenneth.starke@cr.k12.de.us to schedule time for walkthrough of Postlethwait Middle School.
- 1.3 Work hours are typically 6:00 am to 4:00 pm and may be extended on an as-required basis. Contractor shall coordinate with owner with a minimum of 48 hours notification if necessary to work outside of typical hours.
- 1.4 Work on site may begin after June 12, 2017. Substantial Completion is targeted for August 22, 2017. School staff returns August 23, 2017.
- 1.5 “Masonry” Subcontractor will be added to Subcontractor list.
- 1.6 There will be no “Alternates” in the project.

- 1.7 At the pre-bid meeting a linear foot amount was given for the flashing remedial work (through wall flashing installation/ masonry removal and replacement). The amount quoted at the meeting was not accurate and was for “order of magnitude” only. Contractors are to determine the quantities from the Construction Documents and existing field conditions.
- 1.8 Contractor to raise roof mounted gas lines to maintain existing clearances. See Pipe Stand Detail, 6/A-102 on drawings for additional information.

3. ***Bids Due: Sealed proposals will be received by the Owner for public opening until 2:30 p.m. (Postlethwait) and 3:30pm (Fifer) local time on Thursday, May 25, 2017 at the Caesar Rodney School District Conference Room, 7 Front Street, Wyoming, DE 19934. Proposals received after this time shall not be accepted. Bidders should be aware that the Owner reserves the right to reject all bids and/or negotiate with the low bidder.***
