Q: On Drawing A10-03 Construction Notes 1 and 2, state 4" min with tapered insulation overlay with 1/2" cover board. Is the total thickness including base layers, tapered insulation, and cover board to be 5" or 4.5" please clarify.

A: Minimum base insulation thickness is 4". Any tapered insulation required will be on top of the 4" base insulation (total thickness will vary). The 1/2" cover board will be on top of 4" base insulation at any non-tapered areas (4.5" thickness) or on top of tapered insulation at tapered areas (thickness varies).
