- 1.1. Bidders are hereby notified that this Addendum shall be and hereby becomes part of their Contract Documents, and shall be attached to the Project Manual for this project.
- 1.2. The following items are intended to revise and clarify the Contract Documents, and shall be included by the Bidder in their proposal.
- 1.3. Bidders shall verify that their sub-bidders are in full receipt of the information contained herein.
- 1.4. Attached are Pre-Bid Meeting Minutes dated 02-08-16 as well as the pre-bid sign-in sheet and a current list of plan holders.
- 1.5. Pre-bid minutes contained in Addendum No 1 will be distributed to all pre-bid attendees. Remaining Addenda to be distributed to plan holders only.
- 1.6. A revised Subcontractor List is attached to replace the current Bid Form Subcontractor List.

2.0 CLARIFICATIONS:

2.1 Drawings and specifications provided on the State website for advertisement purposes should not be used for bidding purposes. Only the drawings purchased at the pre-bid or through FCA's office should be used for bidding purposes.

- 2.2 The gym curtain divider curtain rod and hardware indicated to be demolished on sheet A11-01 (note 13 and note on floor plan) has already been removed by the Owner. Remove demolition of existing gym curtain hanging bar /hardware from scope of work.\
- 2.3 Add 'Wood Athletic Floors' to the subcontractor list.
 - 2.3.1 Based on the floor conditions observed during the Pre-bid walk through, the wood floor currently located on the bleachers walls between column line E2.5 and E5.5 for at each side (column line EF & EC) will need to be sanded down from the face of wall out toward the playing court a distance of 5'-4". Sand the floor surface to remove all scratches and to provide a level floor surface.
 - 2.3.2 Re-finish the sanded floor to be level with adjacent floor surface with a minimum two coats of water base urethane, wood athletic floor finish. Acceptable manufactures are:
 - 2.3.2.1 Bona Sport Super Sport
 - 2.3.2.2 Buckeye Arena 300
 - 2.3.2.3 Approved equal.
 - 2.3.3 Acceptable Installer/Refinisher: The Wood Athletic Flooring subcontractor shall be recognized as an experienced wood athletic floor repair/refinisher able to submit a list of completed projects of similar magnitude and complexity over a two-year period.
- 2.4 The Audio Video equipment cabinet and components (note 13 on sheet ED11-01) will be relocated by the Owner. Contractor shall rework any conduit to relocate the system. The Owner will provide cabling to equipment components.

- 1.0 NOTES -
 - 1.1 The project is a state of Delaware project and is subject to Delaware bidding requirements. See bid documents.
 - 1.2 Attendance at this meeting was mandatory for General Contractors bidding the project.
 - 1.3 Only General Contractors can bid project and must purchase construction documents.
 - 1.4 Prevailing wage rates and reporting are required. Prevailing wage rates are indicated in the specification.
 - Bid due date was indicated as identified in specification: 3:00 p.m. local time on Tuesday, February 20, 2018, at the School District Administration Office. One hard copy of bid documents will be acceptable.
 - 1.6 Scope of work and construction schedule was discussed for the project.

- 1.7 The Contractor will be responsible for developing means and methods to protect existing flooring and finishes.
- 1.8 The contractor will be responsible for obtaining permits. Plans are currently approved by the Delaware State Fire Marshal and the State of Delaware Architectural Accessibility Board. Copies of the SFM and AAB will be provide to the selected contractor.
- 1.9 The project is not seeking LEED certification.
- 1.10 The State Mandatory Drug Testing Program Affidavit is required to be submitted with the proposal for the General Contractor. Affidavits for all listed subcontractors will be required certifying compliance or will have a program in place prior to contract award.
- 1.11 A listing of the subcontractor list was read. There were no additions or subtractions the list.
- 1.12 Following the meeting during a walk-through of the gymnasium, one of the contractors indicated that the flooring beneath the existing bleachers had some rough surfaces that could collect debris or effect the performance of the new telescoping bleacher operation.
 - 1.12.1 Based on the floor conditions observed, we plan to add sanding and refinishing a portion of the wood floor currently beneath the bleachers. Since finishing of this floor will need to be performed by a specialty contractor, In addendum No. 1, we will add 'Wood Athletic Floors' to the subcontractor list.
- 1.13 Warranties must meet minimum State of Delaware two-year requirement or greater as indicated in specifications.
- 1.14 The gym curtain divider curtain rod and hardware indicated to be demolished on sheet A11-01 (note 13 and note on floor plan) has already been removed by the Owner.Remove demolition of existing gym curtain hanging bar /hardware from scope of work.
- 1.15 Substitutions must meet specification requirements and must be submitted not later than 10 days prior to bid due date. Approval or denial of substitution requests will be listed in addenda.


