Sealed bids for **ARNG2314-BBTSELECT – Bethany Beach Training Site Electrical Resiliency**, will be received by the Delaware Army National Guard by mail at the Security Officers Desk in the Main Lobby of the Biden National Guard/Reserve Center, 1 Vavala Way, New Castle, Delaware 19720 **until 1:00 PM local time on Wednesday, September 10, 2025**, at which time they will be publicly read aloud in the Multi-Purpose Room.

Bidders are required to show identification at the Guard Booth when entering the site and must sign in at the Security Officers desk once inside. Please allow sufficient time to comply with these requirements. No exceptions. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project includes the construction of electrical system improvements including primary distribution system upgrades, on-site generation, PV upgrades and a Battery Energy Storage System to support the Post.

Attention is called to the construction schedule as detailed in the Contract Documents.

A MANDATORY Pre-Bid Meeting will be held on Tuesday, August 19, 2025 at 11:00 AM local time at the Bethany Beach Training Site, 163 Scannell Boulevard, Bethany Beach, DE 19930, for the purpose of establishing the listing of subcontractors and answering questions. Representatives of each party to any Joint Venture must attend the meeting. ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.

Sealed bids shall be mailed and addressed to the Delaware Army National Guard, 1 Vavala Way, New Castle, Delaware 19720; ATTN: Brittney M. Poore, Business Manager. Each bid must be accompanied by a bid security equivalent to ten percent of the bid amount and all additive alternates. The successful bidder must post a performance bond and payment bond in a sum equal to 100 percent of the contract price upon execution of the contract. The Owner reserves the right to reject any or all bids and to waive any informalities therein. The Owner may extend the time and place for the opening of the bids from that described in the advertisement, with not less than two calendar days' notice by certified delivery, facsimile machine or other electronic means to those bidders receiving plans.
