INVITATION TO BID**

Sealed bids for **OMB/DFM Contract No. MC1002001111, Delaware State Police Headquarters Boiler Replacement**, will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, by way of the Bonfire Portal at <https://DFM.bonfirehub.com> until **1:00 PM local time on July 8th, 2026**. Bidder bears the risk of late submission.

Bids will be opened and read aloud at **2:00 PM local time on July 8th, 2026** at the Haslet Armory, 122 Martin Luther King Blvd. S., Dover, DE 19901.

The project involves the replacement of the existing boilers and their associated system pumps. There will be (2) new boilers, (2) new boiler pumps, and (2) new system pumps, as well as a new flue stack at the Delaware State Police Headquarters located in Dover, Delaware.

A **MANDATORY** Pre-Bid Meeting will be held on **June 16th, 2026 at 9:00 AM local time at the Haslet Armory in Rm. 133 at 122 Martin Luther King Blvd. S., Dover, DE 19901**, for the purpose of establishing the list of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**

Each bid must be accompanied by a bid security equivalent to ten percent of the bid amount and all additive alternates. The successful bidder must post a performance bond and payment bond in a sum equal to 100 percent of the contract price upon execution of the contract. The Owner reserves the right to reject any or all bids and to waive any informalities therein. The Owner may extend the time and place for the opening of the bids from that described in the advertisement, with not less than two calendar days' notice by certified delivery, facsimile machine or other electronic means to those bidders' receiving plans.
