Sealed bids for **OMB/DFM Contract No. MC3804000148 – OMB/DFM – Plummer Community Correction Center – Herron Building Bath/Shower Renovation** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Haslet Armory Building, 122 Martin Luther King Jr. Blvd. South, Dover, DE 19901 until **1:30pm** local time on **May 21, 2025**, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

The project is to renovate the multi-person toilet and shower rooms located within the Herron Building at Plummer Community Correction Center, Wilmington, Delaware. Renovations include but are not limited to the demolition of interior masonry walls, plumbing fixtures, HVAC and electrical fixtures and the installation of new metal stud walls, stainless steel wall panels and continuously welded hygienic vinyl wall covering, epoxy resin flooring systems, new electrical, mechanical and plumbing fixtures & devices.

A **MANDATORY** Pre-Bid Meeting will be held on **April 17, 2025**, at **1:30pm** local time at the State of Delaware, Office of Management and Budget, Division of Facilities Management, in room 133 of the Facilities Management Office in the Haslet Armory Building, 122 Martin Luther King Jr. Blvd. South, Dover, DE 19901, for the purpose of establishing the listing of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**

Sealed bids shall be addressed to the Division of Facilities Management, Haslet Armory Building, 122 Martin Luther King Jr. Blvd. South, Dover, DE 19901. Each bid must be accompanied by a bid security equivalent to ten percent of the bid amount and all additive alternates. The successful bidder must post a performance bond and payment bond in a sum equal to 100 percent of the contract price upon execution of the contract. The Owner reserves the right to reject any or all bids and to waive any informalities therein. The Owner may extend the time and place for the opening of the bids from that described in the advertisement, with not less than two calendar days notice by certified delivery, facsimile machine or other electronic means to those bidders receiving plans.
