Sealed bids for **OMB/DFM Contract No. MC3806000024 – Hazel D. Plant Women's Treatment Facility – AHU Replacements** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, Haslet Armory, 122 Martin Luther King Jr. Blvd. South, Dover, DE 19901. Bids will be accepted until 2 p.m. local time on Thursday, October 24th, 2024. Bids will be opened and read aloud at 2 p.m. local time on Thursday, October 24th, 2024, in the first floor Conference Room #133 of the Haslet Armory, 122 Martin Luther King Jr. Blvd. South, Dover, DE 19901. Bidder bears the risk of late delivery. Any bids received after the stated time will be rejected and returned unopened.

Project involves the replacement of (4) rooftop air handling units and (1) split system air handling unit serving the facility. The units to be replaced are of varying capacities.
