INVITATION TO BID

Sealed bids for **Red Clay Consolidated School District Contract No. 2-25-37 – Major Capital Program Electrical Pre-Purchase** will be received by the Red Clay Consolidated School District until 2:00 PM local time on July 16, 2025, at which time they will be publicly opened and read aloud in the Conference Room at the **Red Clay Consolidate School District Facilities Offices, located at 1798 Limestone Road, Wilmington, DE 19804**. The successful bidder must post a performance bond and payment bond in a sum equal to 100 percent of the contract price upon execution of the contract. The Owner reserves the right to reject any or all bids and to waive any informalities therein. The Owner may extend the time and place for the opening of the bids from that described in the advertisement, with not less than two calendar days' notice by certified delivery, facsimile machine or other electronic means to those bidders receiving plans.
