- 1.1 Bidders are hereby notified that this Addendum shall be and hereby becomes part of their Contract Documents, and shall be attached to the Project Manual for this project.
- 1.2 The following items are intended to revise and clarify the Contract Documents, and shall be included by the Bidder in their proposal.
- 1.3 Bidders shall verify that their sub-bidders are in full receipt of the information contained herein. Bidders shall acknowledge receipt of each addendum on their Bid Form.

**2.0 CLARIFICATIONS**

- 2.1 Drawings and specifications provided on the State of Delaware procurement website for advertisement purposes should not be used for bidding. Only the documents issued at



the Pre-bid Meeting or purchased directly from F-C Architects should be used for bidding purposes.

- 2.2 This and all future addenda will be emailed to all planholders at the addresses given on the sign-in sheet.
- 2.3 Please see attached Pre-bid Meeting Minutes and Attendee Sign-In Sheet dated 04-24-2025 and current Bid Set Registry. These documents are incorporated into this Addendum.
- 2.4 Bidders are reminded that the subcontractors they list on the Bid Form must be the subcontractors who perform the work. Bidders listing themselves as performing any portion of the work must be qualified, licensed, and manufacturer-certified to do so.
- 2.5 Chain-link fencing specifications indicate performance requirements, manufacturers are not listed. Products submitted that do not meet or exceed specification requirements will be rejected.
- 2.6 Following bid approval, The contractor that is awarded the project will need to provide a separate billing schedule of values for each school to accommodate district auditing.

### 3.0 QUESTIONS

- 3.1 Q: Is there any benefit to purchasing plans from the architect. The Mymarketplace site posted the plans.

A: Yes - Plans are not supposed to be posted on the Mymarketplace website and should only be released to potential bidders following filling out a request form and gaining approval from the Owner (Seaford SD). If they are released following owner approval, it is only to allow a contractor to view, to determine if they are interested attending the Pre-bid meeting and potentially bidding the project. These are not formal bid documents. Any changes to the bid documents made by the architect after initial submission to Mymarketplace are included in drawings and specification issued by the architect.

The Advertisement for bid indicates: Contract documents will be available to bidders, upon request, in electronic format after the Pre-Bid Meeting for a \$25.00 nonrefundable fee.

During the pre-bid meeting it was stated: Contract documents must be obtained from Fearn-Clendaniel Architects. State of DE My Marketplace documents are for reference only and are not to be used for bidding.

During the pre-bid meeting it was stated: Pre-Bid attendees will receive the first addendum containing pre-bid meeting minutes and sign-in sheets. Only registered planholders of the bidding documents will receive addenda thereafter. Addenda will be



emailed to the address provided by the bidder. (Only planholders listed on the Bid Registry can submit a bid for this project).

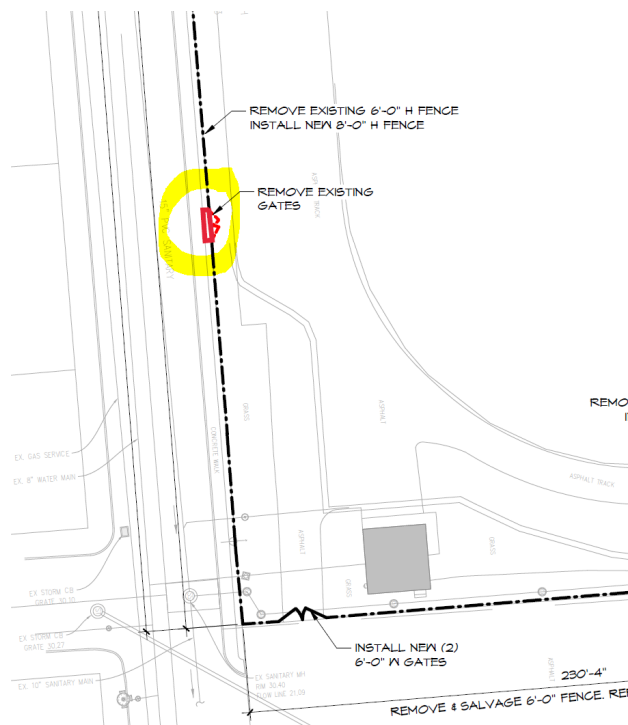
**1.0 NOTES**

- 1.1 The project is State of Delaware funded and is subject to Delaware bidding requirements. See bid documents.
- 1.2 Bids will be accepted from Prime Fencing Contractors or General Contractors only. Attendance at this meeting was mandatory for bidding the project.
- 1.3 Contract documents must be obtained from Fearn-Clendaniel Architects. State of DE My Marketplace documents are for reference only and are not to be used for bidding. FCA will distribute the bidding documents electronically for those wishing to purchase them. Bidding documents are available for purchase from FCA's office in Newport, DE, at a cost of \$25.00 via cash or check made out to Fearn-Clendaniel Architects. Contact FCA [Mark Ballintyn at mark@fcarchitects.net](mailto:mark@fcarchitects.net) to purchase contract documents
- 1.4 Pre-Bid attendees will receive the first addendum containing pre-bid meeting minutes and sign-in sheets. Only registered planholders of the bidding documents will receive addenda thereafter. Addenda will be emailed to the address provided by the bidder.
- 1.5 Prevailing wage rates and reporting are required. Prevailing wage rates are indicated in the specifications.

- 1.6 Bids must include Bid Bond of 10%, Non-collusion Statement, Subcontractor List, Addenda acknowledgement, and contractor drug testing affidavit. The successful bidder will be required to submit Performance / Payment Bond for 100% of the contract amount and subcontractor drug testing affidavits prior to execution of the contract.
- 1.7 Bid due date was announced as identified in advertisement: **2:00 pm local time on May 8, 2025**. Please note that bids are to be delivered to the Seaford District Administrative Offices at 390 N. Market Street, Seaford, DE 19973. The address is listed in the specifications. One hard copy of the bid documents will be sufficient. Faxed or emailed bids will not be accepted. Mailed bids received after the bid due date and time will be returned to the sender unopened.
- 1.8 Project Schedule is noted in specification Summary 01 10 00.
- 1.9 The contractor will be responsible for obtaining permits. FCA will provide PDF files signed and stamped in electronic format by the architect and engineer of record for use in obtaining permits.
- 1.10 Working hours are 7:00 to 4:00, Monday through Friday, except as otherwise indicated or negotiated with the Owner, with a minimum of 72 hours' notice.
- 1.11 The school will be partially occupied during the construction period with office staff and custodial personnel. Contractor shall coordinate schedule with owner to allow for mowing of grass.
- 1.12 A construction office trailer is not required, but may be placed if desired. Temporary meeting space can be accommodated within the building if necessary, in coordination with the Owner.
- 1.13 Temporary utilities - existing electric and water utilities are available for use without metering or charges. Electric and water connections beyond available services are the contractor's responsibility and shall be included in the bid amount including returning any modified utilities to their original condition.
- 1.14 Contractor will be responsible for protecting and restoring existing site conditions during work and infilling soil and germination of grass in areas where concrete slabs are indicated for removal.
- 1.15 State of Delaware mandates a minimum of 2 years comprehensive material and labor warranty on all work in the project. Specific items may have longer warranty terms as indicated in the project manual.
- 1.16 Contractor to provide temporary sanitary facilities.
- 1.17 Storage and laydown areas to be coordinated with the Owner following award of contract.
- 1.18 Contractor is responsible for security of their equipment and materials.

- 1.19 Liquidated Damages are waived for this project. Work not 100 percent complete prior to the final completion date may be completed by the Owner's forces with all associated costs back charged to the Prime Contractor.
- 1.20 The Subcontractor List was recommended, reviewed, discussed and approved by all in attendance and with Owner. A revised bid form indicating subcontract category listing will be distributed in Addendum No. 1. Subcontractor list to include: Fencing Installer. Any Second or Third-tier subcontractors must be listed in the appropriate line.
- 1.21 Scope of work including alternates were outlined using the construction drawings and information indicated in the specifications. Contractors shall verify all dimensions and quantities.
- 1.22 All questions should be submitted to Project Architect Mark Ballintyn at FCA's Wilmington office via email to [mark@fcarchitects.net](mailto:mark@fcarchitects.net).
- 1.23 The deadline for substitutions is 10 days before the bid due date. Bidder questions will only be accepted from or through contract document holders on the planholder's letterhead or email.
- 1.24 The deadline for questions is 7 days before the bid due date. Bidder questions will only be accepted from or through contract document holders on the planholder's letterhead or email.
- 1.25 The final addendum will be issued no later than 2 days prior to the bid due date. Exceptions: withdrawal of solicitation, extension of due date, or change of opening location.
- 1.26 Following the meeting contractor were invited to make observations at each site. The following items were questioned and discussed:
  - 1.26.1 Existing Chain-link fencing at Central Elementary School was observed to be at 42" height. Drawings indicate new fencing to be 48" high. All new fencing at Central Elementary School to be 42" height.
  - 1.26.2 Drawings indicate a top and bottom rail. This was revised, the bottom rail shall be replaced with a tension wire except for gates which shall have bottom rails.
  - 1.26.3 All chain-link fencing fabric & tension wire to be black per specifications.
  - 1.26.4 Owner indicated all Framework and posts shall be galvanized steel pipe per specification with exception as noted below:
    - 1.26.4.1 At Seaford HS Stadium, all framework and posts shall be Polymer-Coated black to match fencing fabric.

- 1.26.4.2 At Frederick Douglass Elementary School, all 8'-0" height fencing framework and posts shall be Polymer-Coated black to match fencing fabric.
- 1.26.5 Contractor is responsible to remove existing fencing concrete footings unless noted otherwise. The Seaford School District will be responsible for disposal of all salvaged post footings.
- 1.26.6 One additional section of concrete sidewalk shall be removed at Seaford High School located at the southwest gates noted for removal. The section to remove aligns with the existing gates and extends to the existing sidewalk along Market Street, See highlighted area below:



- 1.26.7 Where gates are noted for removal at Seaford High School along Market Street, infill openings with new fencing.
- 1.26.8 All new gates to have Box Hinges. Offset hinges are not acceptable.
- 1.26.9 At Frederick Douglass Elementary School, the portion of fencing to be installed in existing asphalt. Contractor shall cut asphalt to provide uniform edges. Contractor can either finish top of concrete footings slightly above asphalt with slope for drainage with perimeter aligning

with adjacent asphalt surface, or contractor can patch asphalt at each post.
