### INVITATION TO BID

Sealed bids for **Seaford School District, Contract No. SEA\_25002A\_EX-FENC, Seaford School District – Fencing Renovations** will be received by the **Seaford School District, at the District Administration Office, 390 North Market Street, Seaford, DE 19973** until **10:00 a.m.** local time on **Thursday, December 18, 2025** at which time they will be publicly opened and read aloud. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

The project involves removal of existing exterior fencing and gates, and installation of new exterior fencing, gates and associated work items at Central Elementary School, Frederick Douglass Elementary School, and Seaford High School.

Attention is called to the construction schedule as detailed in the Bid Documents.

**Only General Contractors or Fencing Contractors may submit bids on this project.**

A **MANDATORY** Pre-Bid Meeting will be held on **Thursday, December 4, 2025 at 10:00 a.m.** at the **District Administration Office, 390 North Market Street, Seaford, DE 19973** for the purpose of establishing the listing of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING BY ALL GENERAL CONTRACTORS AND PRIME FENCING CONTRACTORS IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**

Sealed bids shall be addressed to the Seaford School District, ATTN.: D. Henry. The outer envelope should clearly indicate: **“CONTRACT NO. SEA\_25002A-EX-FENC – SEAFORD SCHOOL DISTRICT – FENCING RENOVATIONS – SEALED BID – DO NOT OPEN”**.

Contract documents will be available to bidders, upon request, in electronic format after the Pre-Bid Meeting for a \$25.00 nonrefundable fee. Bidders will not be subject to discrimination on the basis of race, creed, color, sex, sexual orientation, gender identity or national origin in consideration of this award, and Minority Business Enterprises, Disadvantaged Business Enterprises, Women-Owned Business Enterprises and Veteran-Owned Business Enterprises will be afforded full opportunity to submit bids on this contract. Each bid must be accompanied by a bid security equivalent to ten percent of the bid amount and all additive alternates. The successful bidder must post a performance bond and payment bond in a sum equal to 100 percent of the contract price upon execution of the contract. The Owner reserves the right to reject any or all bids and to waive any informalities therein. The Owner may extend the time and place for the opening of the bids from that described in the advertisement, with not less than two calendar days notice by certified delivery, facsimile machine or other electronic means to those bidders receiving plans.
